COVID-19 PROTECTION

If you, or another named passenger on your booking, is unable to travel due to contracting Covid-19 within 21 days of your departure you will be able to amend your booking to travel on an alternative date during Winter 2021/22 or transfer the booking to Winter 2022/23.



FREE AMENDMENTS / FLEXIBILITY

Up to the 1st October 2021, you can transfer your booking for Winter 2021/22 (coach or own transport) to an alternative date during the same season, or to a date in the following season (Winter 2022/23), giving you total flexibility over your booking. If your booking is by air, this can also be amended up to the 1st October 2021 if we have not yet booked the flights. We will consult with you prior to booking flights to ensure you have the flexibility you need.



REFUND GUARANTEE

We understand there are circumstances that may make it difficult for you to transfer your booking to a different date or season. We're therefore pleased to offer you the opportunity to cancel your booking with refunds guaranteed, allowing you to book with complete confidence. The refund guarantee will be activated should certain restrictions be in force at any point up to the 1st October 2021 – please see the refund activation list below.



REFUND ACTIVATION

You will automatically have the right to cancel your booking and be refunded should any of the following restrictions be in place up to the 1st October 2021.

- The FCDO advising against all but essential travel to Italy, or a country en-route that we cannot avoid in your travel arrangements.
- The requirements to quarantine on arrival into Italy or on your return to the UK.
- National or regional lockdowns in the UK which prevent travel.
